# Minutes for Knox County Indiana County Commissioners

#### Call to Order

A meeting of The Knox County Commissioners was held on May  $6^{th}$ , 2020 in the Commissioners room of the Knox County Courthouse. It began at 10:00 am and was presided over by President Kellie Streeter.

#### **Organizational Issues:**

#### Resolutions

### **Other Reports**

Highway Superintendent Benji Boyd opened 2 bids for the 2020 CCMG project which is a resurfacing project between Emison and Oaktown. The two bids were: A) Milesone Paving for \$721,095 and B) E&B Paving for \$691,777.

President Streeter discussed the upcoming project of re-paving the parking lot of the Knox County Courthouse. Two bids had been received: A) E&B Paving for \$43,370 and B) Milestone Paving for \$34,500. An additional appropriation will be asked for from the County Council for this project.

The Commissioners discussed that Knox County had been awarded grant monies from OCRA for county businesses affected by the COVID 19 pandemic. The next steps in the process are to draft applications, create a committee to decide on grant awards, and to coordinate with SIDC for a public hearing on the matter.

The next meeting of the Knox County Commissioners will be held on May 19th, 2020 at 6pm.

A public hearing regarding the OCRA small business grants will be held on May 19<sup>th</sup>, 2020 at 5:30 pm.
