Matt Sward from SIDC updated the board on the EDA Grant for the Pantheon. SIDC is supplying requested information to the EDA.

The Knox County Board of Commissioners chose to not extend the COVID-19 emergency declaration.

The Board discussed the creation of a Solar Farm land use ordinance. The Board agreed to sign a letter of engagement with Barnes and Thornburg for legal services so that legal services would be ready if needed. The board hoped to have an ordinance ready for reading by the next meeting.

Local implementation of CARES Act Relief Fund – Vincennes Township Fire filed a claim for \$15,400. Kellie Streeter signed the claim as required by the Indiana Finance Authority.
