Knox County Surveyor: Additional appropriation in Corner Perpetuation fund for \$10,000 in Equipment. Motion by Jay Yochum and seconded by Harry Nolting to approve. Motion passes 7-0

Knox County Highway: Additional appropriation of \$17,596 for money received from INDOT for Bridge 382. Motion by Randy Crismore and seconded by David Culp to approve. Motion passes 7-0

Knox County Solid Waste: Additional appropriation of \$9,989.22 for salary increases. Motion by Randy Crismore and seconded by Rich Chattin to approve. Motion passes 7-0

Knox County Clerk David Shelton updated the board on preparations being considered regarding the Corona Virus and potential election impact.



**Adjournment**


Jay Yochum moved and Kevin Meyer seconded, that the meeting be adjourned, and this was agreed upon at 5:43 pm.
