Other Reports




President Streeter informed the board that the Knox County ^{Development} ~~Redevelopment~~ Corporation has hired a new CEO, Chris Pfaff.

Trent Hinkle moved, Kellie Streeter seconded, and the meeting was adjourned 7:49 pm.






