Call to Order

A meeting of The Knox County Council was held on August 11th at Vincennes City Hall. It began at 5:00 pm and was presided over by President Bob Lechner, with Knox County Auditor Micheal Morris as secretary.

Attendees

Voting members in attendance included Kevin Meyer, David Culp, Randy Crismore, Robert Lechner, Jay Yochum, Richard Chattin, and Harry Nolting.

Main Motions

Motion: Moved by David Culp and seconded by Harry Nolting to approve the agenda with the following additions: Clerk David Shelton, and review of estimated maximum levies for taxing units. Motion passes 7-0

Motion: Motion by Harry Nolting and seconded by David Culp to approve the minutes from July 14th, 2020. Motion passes 7-0

Motion: Moved by Harry Nolting and seconded by Rich Chattin to fill 2 vacancies in the Prosecutor's office. Motion passes 7-0

Motion: Moved by Kevin Meyer and seconded by Randy Crismore to fill 2 vacancies in the Sheriff's department: one jailer and one road deputy. Motion passes 7-0

Motion: Moved by Robert Lechner and seconded by Harry Nolting to approve a non-binding resolution on maximum levies for taxing districts with no recommendations for the tax year 2021. Motion passes 7-0

Additional and Transfers

Knox County Prosecutor: Moved by Jay Yochum and seconded by Randy Crismore to table a transfer to \$5,000. Motion passes 7-0

Knox County Commissioners: Additional appropriation of \$35,000 for the creation of a Human Resources Director position. Request dies for lack of a motion.

Knox County Sheriff: Moved by David Culp and seconded by Jay Yochum to approve an additional in the amount of \$6,024.09 for deputy salaries. Motion passes 7-0

Knox County CASA: Moved by Randy Crismore and seconded by David Culp to approve a transfer of \$2,000. Motion passes 7-0

Knox County CASA: Moved by Randy Crismore and seconded by Richard Chattin to approve an additional of \$4,053.55 in grant money. Motion passes 7-0

Knox County Parks and Recreation: Moved by David Culp and seconded by Randy Crismore to approve two transfers, \$8,000 and \$5,000. Motion passes 7-0

Other Reports

Knox County Clerk David Shelton discussed with the board the upcoming 2020 election. He also reminded the board that he will be asking for funds to be deposited into his Election Equipment non-reverting fund.

Knox County Commissioner Trent Hinkle discussed the creation of a Human Resources Director position for Knox County Government.

Coroner Brian Hagen discussed with the board his transfer request from the July 14th meeting and why it had been denied by the DLGF.

Officers' Reports

Randy Crismore informed the board that the Solid Waste Management District is still looking for a new building.

The next meeting of the Knox County Council will be held on September, 8th at 5 pm at Vincennes City Hall.


Budget hearings will be held September 14th through the 17th at the Knox County Courthouse from noon to eight pm.
