Motion: Moved by Jay Yochum and seconded by Rich Chattin to fill vacancies in the following departments: Knox County Prosecutor (deputy prosecutor), Knox County Probation (2 full time positions), Knox County Clerk (one part time position), and Knox County Superior Court (FRC part time position).
