Minutes for Knox County Indiana County Commissioners

Call to Order

A meeting of The Knox County Commissioners was held on October 6th, 2020 in the Commissioners room of the Knox County Courthouse. It began at 10:00 am and was presided over by President Kellie Streeter.

Organizational Issues:

Motion: Moved by Trent Hinkle and seconded by Tim Ellerman to approve the agenda with the following additions under New business: SIDC, request for planting a tree to honor Judge Johanningsmeier. Motion passes 3-0.

Other Reports

Knox County Highway Director Benji Boyd informed the board that he will be seeking an ordinance to restrict truck traffic on Mays Road. He also informed the board that the Highway department has applied for a CCMG grand for the Old Bruceville Rd project.

The courthouse parking lot will be resurfaced on Saturday October 17th.

Brett Dawson, president of the Wheatland Town Board, appeared before the board to discuss the sewer system that the town is planning on building. The project will require Wheatland to acquire a loan from the USDA. Wheatland is asking Knox County to provide funding aid, so they can complete several requirements to receive the USDA grant.

Draft ordinance 2020-4 rezoning from A-2 to I-2 to be sent to Area Plan before 1st reading.

Draft ordinance 2020-5 rezoning from A-2 to C-1 to be sent to Area Plan before 1st reading.

President Kellie Streeter informed he board that the SIDC CDBG grants were now over the income threshold and the SIDC is exploring other options. President Streeter also updated the board on the CARES Act Relief fund grant.

The next meeting of the Knox County Commissioners will be October 20th, 2020 at 6:00 pm.
